It is a fact that workers are the backbone of the country's economy. It is well said that a satisfied worker could play an important role in the social economic development of a country. Industrial development depends on the well being of industrial workers.

1. Role of National Industrial Relations Commission:

In terms of section 22-A of I.R.O 1969 one of the functions of the commission is to advice trade unions and federations in respect of education of workers. in the essentials of trade unionism, including education in respect of their rights and obligations and to secure provisions and facilities required and to apportion the cost there of between the provincial and federal government industry-wise trade unions, federation of such trade unions and federation at national level of employers in such a manner as may be considered equitable by the commission.

2 Child Labour:

Child labour is another hazard of the important policy. By law, children below the age of 14 are not allowed to pursue health deteriorating occupations. Against that law, 12 to 13 million children work in the informal sectors. Large number of girls under 12, working in urban areas, is well over a million. Carpet industry, family establishments, cottage industries and agriculture are some of the areas where the worse form of child labour exists. 3. The role of women workers:

No doubt, woman constitute an important section of any civilized society. Pakistan stands aloof from the rest of the world in that claim. Law provides a working women with security but society denies her that right. Few years passed there was established a commission to deal specifically with the problems of women. Research of the commission centered around examining the existing laws discriminatory against women workers, and the possibility of amending them to improve the stratus of women workers in Pakistan. Majority of women work in the area of stitching, packing, carpets industry. The age at which there women start working, stretches form the range of 10 year old to over 55 most of the women labour are between 14 to 19 years. Usually, women are contacted by the middle men to work either at a factory or else-

where. Wages of the women a shockingly low. Moreover, th manner in which work is distributed to the women makes it difficult to have a fixed rate of payment. Being illiterate, they are further exploited by the middle men who demand their commission. With the result, that there is no government policy to redress it. In any other country. they can be liable to legal prosecution. But in Pakistan a women cannot bring about enough evidence to support her claims. Reports published by the human rights commission in Pakistal point out the inability of the government to solve the labou problems, especially as far as f male workers are female work ers are concerned. The worke all over the world are celebra ing May Day, commemorating the beginning of the worke movement which started on th day in 1886 with the martyrdo of the Chicago workers wh were demanding on 8-hour wor day and protesting against the practice that required them to put in humanly impossible long hours of work. So we should give the workers their dues before drying of their perspiration.
