Last year alone there were 3,748 cases of violence against women reported around the country of which 1,256 fall under honour killings. Seventy per cent of such cases are unreported, undetected and not even registered.

The military and civilian governments, which have ruled us since independence, can never be absolved of being responsible for the prevalent state of affairs. They pursued their agendas and narrow selfish vested interests by flagrantly and unashamedly patronizing, in fact, safeguarding the roles
