Humans violating human rights

THEN we talk about UNO' Commission on human rights and then watch television, glance at the newspapers and magazines, we ome across the bitter realities of times, we see the humanity in mense pathos, their miseries

d deprivations have crossed all nhits. When we talk of human rights we must know the vast horizons it covers and the broad berspective in which this "socalled term is used. The food, shelter & clothing are not the only basic rights of human beings but it is essential that they must be provided the security of life & property, their self-respect is protected and they are treated equally before law. Similarly the freedom of speech and expression must be granted, so that if he is against something he can express his views, or protest and critcise what he thinks is wrong. Every person must be free to follow his beliefs and practices his religion.

For the protection of these human rights UNO's General Assembly passed the human rights charter on December 10 1948 which says that all humans are born free and equal, their rights and respect must be protected and that they must follow, what Islam calls, brotherhood of man. The basic provisions of human rights charter are as follow:

• Every person has got the right to safeguard his life, liberty and personal freedom

· No one can be arrested, jailed or exiled at the orders of a ruler without due process of law.

• Every one is equal before the law and without any discrimination has equal access to justice.

Family is a basic and natural requirement of the society and must be protected by the society and state.

• Every person has right to posess property individually or col-

Every person must be granted an opportunity in his state to have government emloyment.

• Every person is free to approach any other person or to work for the development of humanity, to maintain brotherhood, to establish healthy relations between the mankind. He is permitted to form any committees for this purpose.

· Every person is allowed to have his own views and is permitted to express himself freely.

· Every one can participate in the cultural development and affairs of his state, and to be benefited from the literature, science and process from such participation. Now when we look around and review the human rights situation, we can find ourselves how UNO has worked to improve this situation. The Cambodian, Vietnam, Korean crisis, the Atomic explosions in Japan may be the stories of the past but Chechenya's situation, the ethnic cleansing in Bosnia are still vivid in our minds. The w tribunals are trying to punish 1 2 violaters but with out any success at all. The justice perhaps will be done in heavens! The war ravaged Afghanistan saw many envoys from the UNO and USA be all in vain.

HE Kashmiris are braving Indian aggression yet the UNO last year decided to scrap off 50 issues from its agenda including Kashmir issue which according to UNO is a dead issue and thus must be discarded. Is this

the justice for which Kashmiris are aspiring? In 1995, 60,000 Zairian Tutsis were forced out of Zair. UNO called for the disarmament of the Hutus but international community played the role of silent spectator. It seems that by the time UNO takes decision thousand would die of hunger, thirst & starvation. The Cyprus conflict between Turkey and Greek is still haunting the UNO's human rights commission. Pakistan's Constitution grants the safety of basic human fights to its citizens but gang rapes, burning of women, sectarian riots, religious strifes, robberies, law and order situation are common headlines of all our newspapers.

The police victimises the innocent people to protect people who are involved in all sorts of dirty Human Y: What businesses, drug trafficking is spoiling our younger generation. Most of our population has no achealth facilities and education. The child labour is a major problem and in fact the result of poverty. The poor parents cannot afford the educational expenses of their children, they can't survive if their kids do not earn for their families.
