The very genesis and philosopy of Islam is founded on the respect for humanity and all the religions. The unity of the origin of mankind is fundamental to Islam. In the first verse of Surah Al-Nisa, Quran says: "O mankind! Be careful of your duty to your Lord

There is another misconception that Islam abrogates and denies the earlier religions. The reality is that Islam continues and confirms the truth revealed through Prophet Abraham and the prophets who came after him. Quran says: "And unto thee have We revealed the Scripture with the truth, confirming whatever Scripture was before it, and a watcher over it."

Islam does not impose itself upon anyone. It respects the rights of the people belonging to other religions and believes in co-existence. Quran is very explicit when it says: "There is no compulsion in (professing any) religion". Quran allows Christians to live by their faith and says: "Let the people of Gospel judge by that which Allah has revealed therein, for he who judges not by that which Allah has re-

vealed is a sinner".

Similarly, Quran exhort Jews to live by the laws revealed to them in Torah. Therefore, religious tolerance is the hallmark of Islam. The conduct of Holy Prophet (PBUH) in the city State of Madina is a splended manifestation of peaceful co-existence of Islam with other religions and cultures. The city State of Madina had its socio-political foundation built on the Charter of Madina - a document signed by more than 44 representatives of local Jewish, Christians, Pagans and other tribes. This Charter, which incidently is the first written constitution of the world laid the edifice of a multi religious society based on principles of equality and justice. The Charter was a social contract that guaranteed internal freedom and autonomy to the people of various religions in deciding their affairs in accordance with their own customs and shariah. The Charter made Muslims responsible for the protection of life, property and honour of all the citizens irrespective of caste, creed, colour and race.

Then the charter the Prophet (pbuh) granted to the Christian monks of Sinai in the year 628 C.E. (Common Era), is a marvelous reflection of respect and religious freedom enjoyed by the Christians in his

This position has been accepted even by the enlightened Western authors. Karen Armstrong in her biography of the Prophet Muhammad (pbuh) writes: "Fighting in warfare might sometimes be necessary but it was only a minor part of the whole Jihad or struggle."
